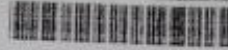
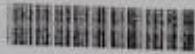

TRUST DEED

This deed of trust is executed at Shahabad (M.) on 15th Day of January, 2020 by Sh. Devinder Kumar Singhal son of Sh. Puran Chand Gupta aged 55 years, Mrs. Kavita Singhal Wife of Sh. Devinder Kumar Singhal aged 53 years, both are the resident of H.No.1236, sector-1, Part-2, Huda, Shahabad (M.) Distt. Kurukshetra and Sh. Deepak Kumar son of Sh. Lovlesh Kumar singhal aged 39 years, Sh. Aman Singla son of Sh. Lovlesh Kumar Singhal aged 33 years, both are the resident at H.no.-9, Sector-1, Huda, Shahabad markanda Distt. Kurukshetra.

Whereas the above said settlers are to setup a trust for charitable purpose.

Whereas the above settlers also desire to donate initial sum of Rs. Twenty one thousand each as initial working capital of the trust.

Now this Trust deed is witnessed as under.

1. Name : "Ganpati Educational And Charitable Trust", here in after referred to as "The Trust"
2. Office : The Registered Office of the Trust shall be at H.No.1236, Sector 1, part-2, Huda, Shahabad (M.), It can be shifted to any other place as decided by the trustees from time to time.
3. Aims and Objectives of the Trusts Are:
To work for upliftment of education, technical education, medical education, social education, business management, prosperity or humanity or charity by way of establishment of different educational research and training institutions under prescribed by the state and central govt. as per resolution passed by the trustees.
4. Borrowing Power:
To meet the financial requirements of the trusts the trust can raise loan from any financial institutions.
5. They will operate the bank account jointly. (President & Secretary)
6. The trust shall have a succession but shall have common seal and shall sue and be sued by the said name.

7. All the income of the trust shall be utilized only for the betterment of the trust and its aim and objectives.

8. Officer of the Trust :

The following shall be office bearers of the trust:

1. President
2. Secretary
3. Members

9. (a) The president and Secretary shall be elected for three years by the trustees. A further period of three years can be extended upto six years by the majority of trustees. The total trustees will be members of the trust.

(b) They shall be entitled to enjoy such privileges as per requirements as the trustees may decided from time to time.

(c) The meetings of the trust will be called by the secretary with prior approval of the president. The notice of the meeting will be served to the trustees three days prior to the meeting.

10. President :

The president shall be elected for three years term and shall be eligible for re-election by the founder trustees/co-opted trustees/ members at the time of election.

11. The Powers and duties of the president shall be as under :

- I. The President presides over the meeting of the trust/ Management Committee.
- II. The President will observe that the rules and regulations are followed.
- III. To be responsible for the better finances, management and progress for the trust and smooth working and management of the institutions of the trust.
- IV. The president of this trust shall be fully competent to constitute and dissolve any committee after getting approval from board of trustees which is constituted in which on within the constitution of the trust.

- V. The President is fully empowered to sanction any amount against to approved budgetary provision after approval from board of trustees.
- VI. The President may be ex-officio chairperson of all the approval Committee sub committees as approved by the trustees.
- VII. The President will have the powers bestowed upon the managing committee as well as General Body in emergent situations only.
- VIII. The President may open & Operate & draw amount from the bank accounts under the counter signature of the secretary.

Secretary:

The Secretary shall be elected for three years by the trust A further period of three years may be extended upto six years by the trustees. The elections will be by way of 2/3 rd majority of the trustees. He is entitled for re-election. He may get honorarium and enjoy such facilities as the trust may deemed fit. He shall be the principal executive officer of the trust for the purpose of laws suits under section 6 of the societies registration act. He shall have the power to delegate any of his powers and duties to any staff members or other trust members.

- I. To execute the work of the trust.
- II. To call meetings of the trust with the prior approval of the president and keep the record of the proceedings of the meetings.
- III. To realize subscription, donations, contributions, loan, fees etc. and to issue official receipts with counter signature of the President and the same will be deposited by him in the bank accounts of the trust on the very day or the next day or the next working day.
- IV. To keep an imprest money or balance up to Rs. 10000 in cash.
- V. To carry out all the official correspondence on behalf of the trust.
- VI. To be fully empowered to sanction bills of revenue nature, cash memos up to Rs. 5000 against the budgetary provisions but such total amount will not exceed Rs. 10000 in a month.
- VII. To menage, supervise and control all the departments, institutions and action of the trust under the guidance and approval of the trustees.

- VIII. To use such other power and to perform such other functions as may be necessary for the trust under the guidance as secretary of the trust.
- IX. He is fully empowered to enter into any contract, agreement for furtherance of the objective of the trust in the large interest and welfare of the trust with the prior written approval of the board of the trustees.

There shall be following class of the members:

1. Founder/ Co-opted Trustees
2. Life Members
3. Honorary Members

The names and addresses of all the trustees have been given in this deed. In case of any vacancy due to death or voluntary retirement the vacancy will be filled with the consent of founder/ co-opted, the trust majority of then board of trustees. With the consent of existing trustees, additional trustee can also be introduced.

Membership:

Any individuals not below the age of 18 years with sound mind and in agreement with helpful in aims and objectives, rules and regulations of the trust, shall be able to become life member of the trust subject to the approval of the board of trustees without the power to vote. The desirous persons shall have to apply to the secretary in the prescribed membership form with the applications fees of Rs. 100/- not to be refunded or adjusted in any case. The Board shall have the full power to accept or reject the form with or without any reason. The decisions of the Board shall be final. The fees for membership will be Rs. 11000. The trust or president can assign any type of work of the trust or institutions, committee and sub-committee to any life members and members.

Removal from membership:

Subject to the approval of the Board any officer or member shall be removed on any one of the following grounds:

- a) For acting in any way prejudicial to the interest of the trust.

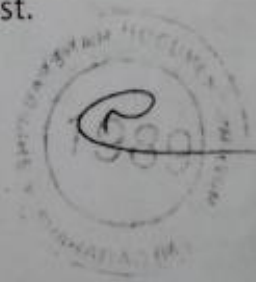

The account of the trust of all its branches and of all its institution shall be kept separately and shall annually be audited by the chartered accountant appointed by the president with the consultation of the board. Such audited accounts shall be placed at the annual meeting of the trust for its approval.

Amendment in rules:

These rules and regulations may be amended and altered by the trust but the new rules and regulation shall not be inconsistent with or repugnant or contrary to the aim and objects of this constitution or of the duties and powers reserved under the rules or any officer or authority of the trust in the 2/3 majority of the trust/trustees.

If any question arises whether any person has been duly elected or appointed or is entitled to member of any authorities or other body of the trust the matter shall be referred to the board of the trustees, decision thereon shall be final.

- a) All properties moveable or immoveable by way of gift endowment purchase or otherwise shall be acquired in the trust, and all such properties when so acquired shall vest in the trust.
- b) All properties so acquired either for the head office or any Branch Office or institutions shall be devoted to and for the purpose according to the intention or donors.

In case of any dispute with the trust or concerning functioning of the trust for any kind of dispute which pertains to the trust would be referred to the president or any arbitrator appointed by 2/3 rd majority.

All the civil suits by or against the trust or its district officer or institution shall be filled only in the civil court at Shahabad (M.) .
